## **Power Connections**

## Warning:

- The input voltage must be between +12V and +125V DC Connecting the positive terminals to ground (0V) and negative terminals to negative voltages (-12V to -125V) is not supported and will cause damage
- Connect earth ground using the lug plate or grounding screw
- Calculate the maximum wire length according to your wire gauge
- DC cables must be a minimum of **12 AWG**
- Connect the positive terminal (+) of the device terminal block to +12V to +125V DC power source, then connect the negative (-) of the terminal block to the 0V/GROUND



2. Connect the earth ground terminal of the device to chassis ground or earth ground



3. Insert the wired terminal block into the power connection on the device

## Wall Mount Option

To attach the unit to a wall:

- 1. Mark the location on the wall where the anchors will be located
- 2. Drill holes into the wall, then insert the provided anchors into the holes
- 3. Screw the two screws provided into the two anchors, leaving enough of the screw exposed to ensure that the unit can be mounted
- 4. Connect the wall mount bracket to the bottom of the device using the provided bracket screws



5. Mount the device onto the screws and ensure that it is mounted securely



**WARNING:** To ensure adequate air flow, the minimum radiating distance between mounted devices is 100mm(3.9in)

## To install the SFP transceivers

- 1. Slide the SFP into the cage socket until it clicks into place
- 2. Lift the latch to lock the SFP



## To remove the SFP transceivers

- 1. Lower the latch to unlock the SFP
- 2. Carefully pull the SFP out of the cage socket

## **DIN Rail Option**

The FortiRugged-60F supports DIN rails with 35mm(1.4in) x 15mm(0.6in) and 35mm(1.4in) x 7.5mm(0.3in) sizes. The minimum radiating distance between DIN rail devices is 100mm(3.9in).

1. Connect the DIN rail bracket to the bottom of the device using the provided bracket screws. Note there are 4 available bracket positions.



2. Position the bottom of the device directly in front of the DIN rail, ensuring that the top of the DIN rail bracket hooks over the top of the DIN rail



3. Rotate the device until the bottom of the DIN rail bracket sits against the bottom of the DIN rail



## Desktop / Extended Feet Option

Your device is already equipped with feet for a flat surface. You can optionally install the extended grey feet for more surface clearance.

- 1. Place the unit on a flat, clean and stable surface
- 2. Ensure there is at least 38mm(1.5in) of clearance for adequate airflow



3. Plug the provided power cable into the rear of the unit and then into a grounded electrical outlet or separate power source
